It was examined by us according to the

(a) and (b),

as well as of the

Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuches (Lebensmittel- und Futtermittelgesetzbuch - LFGB) in the version of the notification of 15 September 2021 (BGBl. I. p. 4253; 2022 I p.28), last amended by article 2 paragraph 6 of the act of 20 December 2022 (BGBl. I p. 2752), §§ 30 and 31),

as far as the influence of the printing blanket is concerned.

Thus, the printing blanket **0150/1.96 IVO** (Flint Group) according to the sample material submitted may be used safely as component of the printing machine for the exterior printing of packaging materials for foodstuffs. It is used for copying the motive onto the food packaging.

This certificate of compliance has a validity of 2 years and consists of 3 pages.
